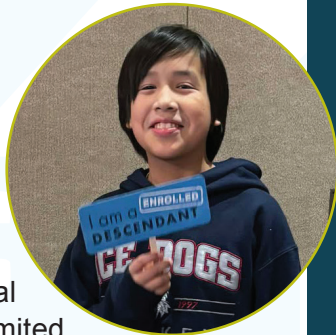
IT'S TIME TO ENROLL

Open enrollment continues for **descendants** of original K'oyitl'ots'ina shareholders! The Class B Stock application and instructions are available to download at kcorp.alaska.com/openenrollment. Hard-copy applications are available by contacting openenrollment@kcorp.alaska.com or (907) 452-8119 x109.

ENROLLMENT ELIGIBILITY

To be eligible for Class B Stock, new descendant enrollees must:

- Be a direct descendant by birth of an original K'oyitl'ots'ina, Limited shareholder who received their shares directly from the corporation (not through gifting or inheritance).
- Be born after December 18, 1971.
- Have at least one-quarter Alaska Native blood quantum. This can only be established through biological parent(s). It CANNOT be met through adoptive parent(s).
- Not be enrolled as a descendant in another ANCSA village corporation.
- Be a U.S. citizen.



THANKS FOR COMING

A big thank you to everyone who attended our descendant open enrollment events this fall. Our goal was to encourage descendant enrollment and to make the application process as simple as possible.

We visited Allakaket, Alatna, Hughes and Huslia to help descendants with their applications. We also held an event in Fairbanks, where attendees received application assistance, visited with board and staff members, enjoyed snacks and drinks, and heard a presentation on the history of K'oyitl'ots'ina, Limited.

APPLICATION FAQs

Q I don't have the original birth certificate from when I was born. What can I do?

A "Original" doesn't mean the exact document provided at your birth; it simply means we need an official document.
We cannot accept photocopies of birth certificates.

Q Where can I get an official copy of my birth certificate?

A You can obtain an original (official) birth certificate by contacting your local Vital Statistics Office:

- For Alaska vital records, call (907) 465-3391 or apply online at health.alaska.gov/dph/VitalStats/Pages/default.aspx.
- For births outside of Alaska, apply online at cdc.gov/nchs/w2w.

Q I'm worried about mailing my birth certificate. Will I get it back?

A Your original birth certificate will be returned to you promptly after your application is processed. We recommend mailing your application, birth certificate and other required documents by certified mail so your application can be tracked. You may also bring your application materials to our office in person.

Q I don't have a tribal ID card. Where do I get one?

A Tribal ID cards for Alatna, Allakaket, Huslia or Hughes Villages are available by contacting the Tanana Chiefs Conference Tribal Enrollment Program at tananachiefs.org/services/tribal-enrollment.

Q How do I enroll into a tribe?

A Descendants may enroll into a tribe through Tanana Chiefs Conference by completing the tribal membership application and providing the required documentation. Find the application and more information at tananachiefs.org/services/tribal-enrollment.

Q I need a Certificate of Indian Blood (CIB). Where can I get one?

A Certificates of Indian Blood (CIB) are available by contacting the Bureau of Indian Affairs:

- In Fairbanks: visit 101 12th Ave., Room 166, Fairbanks, AK. 99701, or call (907) 456-0522 or (800) 822-3596.
- In Anchorage: visit 3601 C St., Suite 1200, Anchorage, AK. 99503, or call (907) 271-4585 or (800) 645-8465.

APPLICATION CHECKLIST

To apply, all applicants will need to submit:

- Class B Stock application
- Original (official) birth certificate
- Certificate of Indian Blood (CIB) or tribal identification card

Additional documents, such as proof of name change, proof of custodianship, paternity affidavit and adoption court order, may be required. If the enrollee is adopted by one or both parents, an adoption form must also be completed.

2025 ANNUAL MEETING

There will be three seats open on the K'oyitl'ots'ina board of directors in 2025. Shareholders will vote to fill the At-Large, Hughes and Huslia seats at the 2025 annual meeting of shareholders. The board candidate application will open in early March, and all shareholders, including our new Class B shareholders, are eligible to apply to serve. ONLINE VOTING RETURNS

Shareholders will once again have the opportunity to vote online with eProxy! Watch for emails and text messages with links to the eProxy and details on how to vote in April. To vote online, you will need to input your birthdate and the last four digits of your Social Security number.
